9. Branch council meeting report

Open Day Report

Open Day on Oct 15 was a successful event with good attendance for our nipper season opening despite the weather.

The interaction from the parents was encouraging with a few new sign-ups for the SRC & Bronze courses and interest in the nipper program with assistance offered for a range of our nipper requirements.

The clothing sale was successful with a clearance of our stock 7 a big thanks to EllenVan Wessell & Leanne Justin for manning the barricades'.

We had a lot of new sign ups & water safety was on hand for the small number of adventurous souls who braved the water.

The presentation for our new beach vehicle was made & despite the failure of the local newspaper & NBN Television to show up on the day the sponsors were pleased with the recognition & our responsibilities have been fulfilled with regards to our grants 7 our sponsors. On a secondary note, the Express Advocate contacted me during the week & a story with pictures appeared in the Thursday edition.

Again, it must be mentioned that this event is notified early in the season & must be prepared for prior to the day for next season.

Ability links meeting report.

On weds/11/0ct I was contacted by Kelly Darcy from the St Vincent de Paul society 'Ability Links program regarding soldiers Beach SLSC's interest in participating in a commonwealth government community program.

This program is aimed at increasing beach access & inclusion for people with a disability by funding & facilitating capacity building projects.

The Ability links team has put together a team of facilitators to establish & work with 27 surf clubs in the Central coast & hunter branches to create environments for attitudinal change around disability & social inclusion.

Basically, the initiative is a facilitated & partially funded program to promote beach access, social inclusion, community awareness

Branch Council Report

On Thurs 12/October North Avoca SLSC was the host for CC Council's lifesaving support funding presentation. All 15 clubs in the branch were represented along with representatives from SLSCC, new mayor of CC Council, Jane Smith along with councillors Chris Holstein & Chris Bourke. Soldiers was represented by Phil Walls & Jim Buckton.

As reported previously the club will receive \$8250.00 for the first ear of the 3-year support agreement. Each club also received a new rescue board.

The presentation was followed by SLSCC AGM & Branch Council meeting

The Branch Council meeting addressed many issues

- Discussion on the recognition of "service hours" within a club to count towards patrol hours. This is still a discussion points however the recommendation from the council was that these hrs were to be "lifesaving specific" i.e. training, assessing, coaching etc.
- All proficiencies complete by Dec 31 for SLSNSW competition. A motion put forward to address the situation whereby competitors not compliant by SLSNSW regulations can still compete at SLSA titles
- SLSNSW has been approached for a public statement on a position regarding the postal survey on SS marriage. The
 motion was moved to remain non-political & not take a public position on the issue.
- All clubs have now been issued a tablet for patrol logins. At present, it has been loaded with the old beach safe app
 as an initial start-up program to train on. Moving to complete online login by Dec 1, 2017
- CC Councils Draft Memorandum of understanding document has been forwarded to SLSCC & the Branch council is to review this document prior to making its' response to CC Council.
- CC council funding is now secured for the next 3 years & includes adjustments for C.P.I to increase in subsequent years.
- SLSCC has put forward an initiative to "adopt a councillor" for each club. This is aimed at fostering a relationship between the new administration & all 15 clubs in the branch. Clubs have been encouraged to invite their "adopted" councillor along with the other representatives from their ward & the mayor to all functions & events at the clubs.
- Nth Entrance are struggling to make patrols & have asked for assistance from the branch to maintain their patrol obligations.
- Discussions on the availability of a branch container for Aussies in Perth
- Expressions of interest in floatation mats for use with the nipper inclusion program. These have been quoted as a 1 off cost of \$900.00 ea. but in bulk orders of 10 the price can be reduced to \$200. Soldiers has been included in the

All in all the start has come around and as per most years patrols seem to fall on there feet. Due to IRB driver shortage we have had to move a few more senior members from a few patrols to balance others mainly due to members not returning. This been said Shane walker, Neville Bunn and Jim Buckton patrols now need boosting with any new members and any new bronze recipients. We seem to have a few numbers in the bronze and SRC course and like all years we seem to get by.

Would like to introduce a new self audit on patrols in the back half of the season to boost members general knowledge and make them not so worried about the CC branch random ones.
