Liam gave a presentation of Accounts for the end of 30th April.

Liam had a Q&A with the meeting participants on the below points.

- That our surplus has increased from \$14,075 30th April 2022 to \$121,032 30th April 2023.
- That the Clubs trade liabilities were \$43,877 30th April 2022, they are now \$19,414 as
 of 30th April 2023.
- Net cash from operating activities increased from \$28,690 30th April 2022 to \$166,507 as of 20th April 2023.
- The Club outgoings recovered \$45,447 30th April 2023 as to the previous year the Club only recovered \$6,409 30th April 2022
- The Club received in grants \$100,916 30th April 20233 as to the previous year the Club received \$26,500 in grants 30th April 2022.
- Total Revenue received 30th April 2023 was \$318,443 compared to, \$162,485 30th April 2022.
- End of year cash on hand as of 30th April 2023 was \$83,679 compared to \$28,304 30th April 2022.
- The biggest difference between the two years is the Club debt in 30th April 2022 was \$43,877 with only \$28,304 cash on hand.
- The Club should now look at budgeting over the next 2 years to save \$70,000pa as a target. The Club needs to concentrate building its savings/investment to at least \$180,000.

- 4. Tony presented the Draft Budgets for 2023/24.

Notes to the budgets.

- Tony said he could not accommodate all that people were looking for, however, if a grant
 was available or a sponsor was identified the budgets would be adjusted.
- After much discussion and pointers from Liam, the Budgets were agreed on, with the view that they are reviewed every three months, so they could be adjusted.
- These Budgets are estimates and the document is a working Document.
